

The Universal Health Declaration is a collection of pertinent information on a passenger that meets the compliance of the travel company and any health restrictions or guidelines regarding who is allowed to travel and enter a geographic region. MyLifeID's health declaration includes information required by airlines, cruise lines, hotels, border patrol, health departments, governments and more. Some of the information includes:

- Passenger full name
- Full Address
- Contact method such as phone and email
- General health, allergy, prescription and vaccination history
- specific questions related to Covid-19, Influenza, tuberculosis and other diseases or conditions which may change from time to time such as measles
- Passenger self-acknowledgement
- Validation by medical personnel and date updated
